

## Consent to Perform Nude

For good and valuable mutual considerations, the receipt of which the parties hereby acknowledge, it is agreed by and between the aforesaid Producer and Performer, as follows:

1. It is essential to the artistic concept, vision, and requirements of said Play that the Performer, in conjunction with \_\_\_\_\_ [his] [her] role as \_\_\_\_\_ therein, will appear nude in, specifically as follows:

2. Performer hereby consents to appear at all performances of the play, nude, at set forth in paragraph 1 above.

3. Producer has, prior to entering into this agreement, furnished to Performer a full copy of the script (as it exists at the present time), and Performer has read same to \_\_\_\_\_ [his] [her] satisfaction and understanding of the nudity required and reasons therefore.

4. The script for this production is a work in progress, and the parties understand that the author may make changes in the script during the contemplated production, in which the performer is appearing. Said changes may necessitate more, or less, nudity, the extent of which is unknown at this time. Performer hereby consents to appear nude as required by said changes.

5. Producer will prohibit—and use his best efforts to prevent—the photographing, filming, video recording of the performer, while \_\_\_\_\_ [he] [she] is nude, unless otherwise agreed to, in a separate writing, signed by the parties.

6. Producer will prohibit—and otherwise use his best efforts to prevent—persons not directly involved with the production from entering the backstage area at all times when the performer may be partially or fully nude either on stage or in the backstage area.

7. As deemed necessary by the director, performer will appear nude in the rehearsals of the specific scenes in which \_\_\_\_\_ [he] [she] will appear nude during actual performances of the production.

8. The performer hereby represents and warrants that \_\_\_\_\_ [he] [she] is of legal age to appear nude as required and to enter into this agreement.
